## CERVICE BYE-LAWS FOR SPORTSPERSON OF SEPARATE SPORTS CADRE

## 1) PREAMBLE:-

In exercise of the powers conferred under Article 81(xv) and all other enabling provisions of the Memorandum of Articles of Association of the Companies, the Board of Directors of Haryana State Industrial Development Corporation Limited do hereby frame 'Service Bye-Laws for Sportspersons of Separate Sports Cadre.'

Sports are an essential and integrated aspect of Human Resource Development as it contribute to the development of a spirited approach to life, enhancement of leadership qualities, bringing about of self realization of one's capabilities and potential and overcoming various fears and inadequacies that exist in individuals. Sports are necessary, for our physical and mental growth and are a way of life. With, the increase in activities and intensity of competition in the field of sports, HSIDC felt the need to create a separate sports cadre in order to enable the Corporation to achieve top honours in the discipline of Volleyball at State, National and International levels and also to contribute its might to Nation pride.

### 2. SCHEME,

HSIDC has adopted Volleyball as a game by creating a separate sports cadre. In order to enable the organisation to achieve top honours, HSIDC is committed to improve the career of its employees.

of sports cadre. Therefore, need for adoption of separate scheme has arisen keeping in view the needs of the corporation for the promotion and development of sports as well as responsibilities of the organisation towards state efforts to encourage sports.

### 3. <u>DEFINITIONS/</u> EXPLANATIONS

In these Bye-Laws words used shall have the following meanings:-

- Sportsperson: means a person appointed in sports cadre on permanent or temporary basis in a regular pay scale but does not include a person engaged on contract (directly or indirectly) contingent paid, work-charged, casual or daily wage basis or on tenure basis.
- il) Appointing Authority: means Managing Director of the Corporation or any other officer to whom authority may be delegated/sub-delegated by or on behalf of Board of Directors for any post(s).
- ill) Sports Cadre:- means a separate cadre to which a sportsperson belongs and within which sportsperson will be considered for promotion.

### 4. RECRUITMENT

- a) Recruitment to various posts in the sports cadre in the Corporation shall be made by adopting any one or more of the following methods:-
  - By direct appointment; or
  - II) By deputation from State Government/Government of India or any Public Sector Enterprise/reputed Private Sector-Organisation.
  - III) By promotion or selection from amongst the staff within sports cadre;
- b) Qualifications and other criteria for direct recruitment have been laid down by the Corporation for each post in Sports cadre which may be amended from time to time by the Competent Authority.

- c) The Direct appointment of a person to any post in sports cadre shall be subject to production of a medical fitness certificate from a Medical Officer/Civil Surgeon of a recognised Govt. Hospital/ Dispensary.
- d) All appointments shall, in the first instance, be on probation
- e) The period of probation shall be one year subject to extension for another six months at the discretion of appointing authority if the performance of the probationer is not found to be satisfactory during the first one year.

## 5. PAY & ALLOWANCES

A Sportsperson shall draw pay & allowances as applicable to the post to which he is appointed and shall be entitled to Annual Grade Increment.

# G. TERMINATION OF SERVICE

The services of sportsperson of Corporation, unless otherwise specifically agreed to, may be terminated by the Appointing Authority:-

- I) In the case of permanent sportsperson by glvlng—three months' notice on either side or, in lieu thereof, pay for the period, the notice falls short of three months.
- ii) In the case of a sportsperson under probation, by giving one month's notice on either side or in lieu thereof pay for the period the notice falls short of one month; and
- iii) In the case of sportsperson on deputation from the Government or any other Corporation/Organisation, by reverting him to his parent department/organisation.

### 7. SENIORITY

There is

The same of the

The cadre- wise Interse-seniority of employees of sports cadre shall be determined by the length of continuous service on the post, provided that in the case of members of cadre appointed by direct recruitment, the order of merit determined by the Selection Committee shall not be disturbed in fixing the seniority notwithstanding the date of joining.

Provided that In the case of two or more persons appointed on the same date, their seniority shall be determined as follows:-

- i) A person recruited by promotion from the service of the Corporation shall be senior to a person recruited otherwise provided that in the case of promotion of two or more persons, their interse-seniority shall be determined according to their seniority in the post from which they have been promoted.
- ii) a member appointed by promotion shall be senior to a member appointed by transfer.
- III) In the case of members appointed by promotion or by transfer, seniority shall be determined according to the seniority of such members in appointments from which they were promoted or transferred.
- lv) In case of persons recruited by direct appointment and their date of joining is same, the older in age shall rank senior to younger.

### 8. PROMOTION

All sportsperson will be considered for promotion after completion of a period of 5 years from the date of their last promotion/recruitment subject to availability of vacancy in their respective cadre. However, the sportsperson representing the national team, if the team secures first/second position in Olympic/ Asian Games/Asian Championship/ World Championship, will be given personal pay and rank promotion in relaxation of minimum qualifying period of five years for promotion, with the approval of the BODs/HSIDC. In such cases, post held by the

incumbent will get upgraded but the same will automatically revert back to its original position at the time of exit of the incumbent from the Corporation or incumbent's promotion against vacant post. However, such number of personal pay and rank promotions will be restricted to a maximum of three during the entire service career.

## 9. DISCIPLINE

All sportsperson are expected to live like true sportspersons. They should be well disciplined, well behaved helping, co-operative, punctual, obedient, hard working and result-oriented.

In case of any act of misconduct on or off the field, disciplinary

proceedings shall be initiated under HSIDC Employees Conduct, Punishment & Appeal Rules, 1993.

## 10. PARTICIPATION IN TOURNAMENTS/CAMPS

Sportsperson recruited in sports cadre will be allowed to participate in following Tournaments/ Camps:-

- 4) National Games.
- 5) National Volleyball Championship !
- 6) Federation Cup
- 7) National League
- 8) Open All India Tournaments
- 9) Inter Departmental National Championship
- 10) Individual player participation in International Tournament
- 11) Asian Club Championship
- 12) Any other Tournaments as may be approved by competent authority.

Any other coaching camp as may be approved by 2) competent authority.

The players as a team or Individually will always participate under the banner of HSIDC. It will be compulsory for player(s) to participate in where HSIDC decides to participate. any tournament/meet Permission may also be granted by HSIDC for participation of sportsperson in Championships/ meets/National/ State coaching camps In country and abroad. Entry fee and participation expenses including TA/DA will be borne by HSIDC in case these are not given by the organiser of such tournaments. They would be eligible for grant of special leave whenever they participate in outside tournaments/meets. Permission may also be granted to a player to play for foreign club with a view to upgrade his skill. In that case his TA/DA and other expenses, if not borne by such club, will be paid by HSIDC. Nonparticipation of sportsperson in tournaments shall constitute an act of Indiscipline. However, exemption may be granted to the players by the competent authority for not participating in tournaments as a result of Injury or III-health.

The logo of HSIDC is to be got printed on the playing Blazers, vests, Jerseys, caps and shirts of the players representing HSIDC at various tournaments/meets.

## 12. NORMS FOR PLAYING EQUIPMENTS, KITS & DIET

Playing kits will be of two categories:-

a) ESSENTIAL KITS

Essential kits are required to be provided to the players each year.

b) NON ESSENTIAL KITS

Non essential kits are to be provided to the players for ceremonial purposes for representing HSIDC at the time of State/ National Tournament when it may be considered necessary.

# 13. SPECIAL SPORTS ALLOWANCE

During tournaments I.e. National Champlonship, Departmental National Championship, National League Championship and National Games special sports allowance will be given to each player @ Rs.100/- per match. For tournaments like State Championship and State Games special sports allowance will be given to each player @ Rs.50/- per match. However, sportsperson attending the National Coaching Camp will be given special sports allowance @ Rs.100/- per day. The number of days will be counted from the date of attending the camp to the date of relieving from the camp. Rates may be revised from time to time by the competent authority.

### 14. INCENTIVE FOR PLAYERS

The individual representing the State team in National games, National Championship, National League, Departmental National Championship and Federation Cup, If the team secures First/Second position will be given cash award as may be decided by the competent authority

- Achievements prior to joining HSIDC shall not make eligible for any player to qualify for grant of incentive.
  - b) The cash award given to the team/coach by the organiser of the tournament/ meet on account of securing any position shall be equally divided by the members of the team including coach.
  - c) The cash award given to the individual by the organiser of the tournament/ meet on account of outstanding performance shall be retained by the concerned.

## 15. INCENTIVE FOR COACH

The coach, who is training the players, will also be given cash award depending upon performance/position of team/players as may be decided by the competent authority.

# 16. COACH/OFFICER INCHARGE GAMES

With a view to ensure maintenance of high standards of excellence, there shall be a coach/officer Incharge having sufficient knowledge of the game, who shall be responsible for:-

- i) Co-ordinating the preparation of coaching programmes of the respective teams for the whole year including participation of the teams in competitions, tournaments and other exposures at District, State, National and International levels.
- ii) Maintaining the attendance, performance, achievements and records of each individual player including physical, and medical test reports.
- lii) Assessing performance, as part of annual performance appraisal, in his capacity as Reporting Officer.
- Iv) Deciding the playing positions of the players keeping the players capabilities in mind.
  - tournaments/ team for Important the Accompanying competitions as decided and to be responsible for the overall administration, management, travel arrangements, boarding and lodging etc. of the team. If for any reason, the Coach/Officer-In-charge of a game is unable to accompany the team on an occasion, it shall be his responsibility to intimate the same to the Appropriate Authority which shall nominate a suitable person with adequate knowledge in the game and ability to manage the players, to accompany the team for tournament/competition.

vi) Submitting detailed reports to the Management after every tournament, giving full details of the conduct and performance of each player including discipline etc.

vil) Ensuring that no player takes part in any other competition/tournament except those approved by the HSIDC.

- viii) Maintaining discipline among the sportsperson including recommending initiation of disciplinary action against defaulters, if necessary.
- ix) Bringing to the notice of the Appropriate Authority of any untoward incident within 24 hours of its occurrence in respect of players, tournaments etc.
- x) Ensuring that the players in the team are always play-worthy.
- co-ordinating the timely procurement of playing kits and equipment-both consumables and non-consumables and ensuring their distribution to the players in the team.
- xii) Looking after the welfare of the players in the team and attending the meetings of Selection Committees for induction of sportsperson.
- xiii) Attendance of the players in the team in office, ground or coaching camp.

## 17. SELECTION OF CAPTAIN/VICE CAPTAIN

Captain/ Vice Captain of the team will be selected on the recommendations of Coach of the team by HOD.

## 18. CATEGORISATION OF SPORTS PERSON

There shall be two categories of sportsperson namely; Category-I consisting of active and full time sportspersons and Category-II consisting of non-active sportsperson who have outlived their active playing career. Sportsperson in Category-II may preferably be
