**OFFICE ORDER**

The matter regarding finalization of the process relating to empanelment of the structural engineers by inviting the applications has been under active consideration of HSIIDC for the purpose of Haryana Building Code, 2017.

2. In this process, it has been observed that the Department of Town and Country Planning, Haryana, Chandigarh, in exercise of powers under Code 10.2 of HBC-2017, has already constituted the following Committee vide order dated 05.08.2022 for having decisions on the applications for empanelment of Structural Engineer, Proof Consultant, Supervising Engineer, Geo Technical Engineer, Third Party Audit Agencies, Fact Finding Agencies and Structural Audit Agencies:

3. As per orders dated 05.08.2022, the entire process for empanelment of Technical Professionals/agencies shall be automated and a software application for the same is already functional at <https://tcpharyana.gov.in/SSO/> and the Chairman, Empanelment Committee is authorized to formulate a Standard Operating Procedure to ensure that the empanelment process functions smoothly.

4. Since a procedure for empanelment of structural engineers under HBC-2017 is already in place, which have representation from HSIIDC also; it is hereby directed to adopt the panel of the technical persons empanelled by the above said Committee, constituted by T&CP, Haryana, for the purposes relating to HBC-2017.


