For seeking objections in the proposal regarding Evaluation of Technical bids for the work of Sweeping of metalled road including berms (ROW) complete in Sector-1, 2 & 3 at Industrial Growth Centre, Saha - Tender No. 2023_HBC_309108_1.

The online tender for the work of Sweeping of metalled road including berms (ROW) complete in Sector-1, 2 & 3 at Industrial Growth Centre, Saha were invited & the period for uploading the tenders was from 13.09.2023 to 29.09.2023. The DNIT amount of said tender is Rs. 54.36 Lacs. The technical bids were opened on 03.10.2023. Total five agencies participated in the bidding process, the details of the agencies are as under:-

 during the last three years, ending 31st March of the previous financial year, should
 not be less than 30% of the value of work. The turn over shall be updated to price
 level of the last financial year at the rate of 8% per year compounded yearly.
- The agency must have executed & completed similar works i.e. works pertaining to Sweeping of metalled road including berms (ROW) during the last seven years:-

- The agency has average financial turnover of Rs. 214.88 lacs of last three years. (Flag-'C')
- 4. Agency has not submitted any completion certificate of similar nature of work.

The agency does not fulfill the conditions of tender because the agency has not comply the condition of work executed by them and the same is intimate to the agency vide letter no. 626 dated 03.11.2023, but the agency does not submit the same. The agency also not submitted the EMD. Therefore the agency is not technically eligible as per the provisions of the bid document.

E) M/s Radhey Prasad Govt. Contractor, H. No. 631, Sector-4, Rohtak.

- The agency is registered with Haryana Engineering Works Portal with ID no. 2021R5291. (Flag-'A')
- 2. The agency has not submitted the EMD and submitted an earnest money exemption declaration form. (Flag-'B')

- The agency has average financial turnover of Rs. 47.10 lacs of last three years. (Flag-'C').
- 4. Agency has not submitted any completion certificate of similar nature of work.

The agency does not fulfill the conditions of tender because the agency has not comply the condition of work executed by them and the same is intimate to the agency vide letter no. 627 dated 03.11.2023, but the agency does not submit the same. Therefore the agency is not technically eligible as per the provisions of the bid document.

In view of above, out of 5 participated agencies only 2 agencies namely M/s The Shri Mohan Co-Op., L&C Society (Sahkaari Sharm and Nirman Samiti Ltd.) and M/s City Service Providers Pvt. Ltd. are meeting the eligibility criteria of the bid document, hence are technically qualified.
